

TYPE OF PLAY: 36 Holes-Stroke Play. 18 holes on each golf course.

ENTRY FEE:

\$15.00 per person, plus green fees. Adult season passes will be honored. Entry fee must accompany entry form to secure a starting time. Make checks payable to: Peoria Park District.

PLAYER ELIGIBILITY:

Amateurs only. No area restrictions. Must be at least 12 years of age.

FLIGHTS:

Flights will be arranged after the first day's play, except for the Championship Flight. A Senior Division will be created pending a minimum of 12 entries.
